GEMS Legacy School, Dubai had approached the Consulate for a No Objection Certificate in connection with shifting grades from 6<sup>th</sup> to 8<sup>th</sup> to new built school campus in Dubai.

2. The school has informed us that the CBSE affiliation was taken for the campus address: GEMS Legacy School, Adjacent to GGICO metro station, Garhoud, Dubai, Po. Box No. 4973 with a campus area of 21400 sq.m. The school will continue to operate on the same campus for primary level (Kindergarten to grade 5). The existing student capacity for the primary is 5100 students.

3. The grades from 6<sup>th</sup> to 12<sup>th</sup> will be moved to the new campus with the same school name as GEMS Legacy School, Dubai. The new address of the school is as below :  
**GEMS Legacy School, near RTA headquarters, Garhoud, Dubai with a campus area of 23500 sq.m.**

4. Currently, the school is having Kindergarten to grade 8 and will be gradually take admission upto class 12. It was found that the requirements of class rooms, infrastructure, laboratories, computer labs and other facilities have been taken care of in the new premises. The school has got the necessary permission from Dubai school regulatory authority - Knowledge and Human Development Authority (KHDA).

3. The Consulate has no objection in relocation of grades from 6<sup>th</sup> to 12<sup>th</sup> to the new campus of GEMS Legacy School, Dubai.
